Request for Proposal (RFP) are required from Engineering Consultancy firms registered with Pakistan Engineering Council (PEC) for the year 2021-22 with relevant **codes-1208 (Power transmission and Distribution system)**, registered with FBR/KPRA (with active status) for the above mentioned work.
2. A firm/joint venture will be selected for the services under Quality Cum Cost Based Selection (QCBS) Method under the procedure/criteria described in the Request for Proposal (RFP) documents.

Engineering consultancy firms are required to submit a comprehensive Technical proposal in English (Original + One copy) and Financial proposal (Original + One copy) in separate sealed envelopes for the services required in the Terms of Reference (TOR's) latest by **24-09-2021 at 11:00 AM**. Technical proposals will be opened on the same date at **11:30 AM** in the presence of the firms or their representatives who choose to attend at the same address. The original and copy of the proposal shall be sealed in separate envelope and marked original and copy. Both these envelopes shall be put in one sealed envelope and addressed to the Director General Provincial Housing Authority KPK.
4. A pre-proposal meeting will be held in the office of the undersigned on **17-09-2021 at 11:00 AM**
5. Consultancy firm having maximum experience in construction supervision of external electrification and distribution systems will be preferred during technical and combined evaluation.
6. RFP documents/TOR's are available in the office of the undersigned and can be obtained on any working day during working hours at least **seven days before** closing date on cash payment of **Rs.1500/-** (Non-refundable).
7. Any other query/information can be obtained from the office of the undersigned on any working day during working hours.
8. The DG PHA may reject any or all the proposals as per provisions of KPPRA rules, at any time prior to acceptance of Request for Proposal (RFP).
