1. The Bidders should be registered with Pakistan Engineering Council (PEC) for the year 2024-25 in Relevant Category & field of Specialization for the Year 2024-25 and Enlisted with Khyber Pakhtunkhwa Housing Authority (KPHA) for the year 2024-25.
2. Bidding documents including instruction to bidders and BOQ can be downloaded up to one day prior to the opening date from KPHA Web Site (<https://www.housingkp.gov.pk/>).
3. A complete set of Bid Solicitation Documents may be obtained at a cost of Rs.1000/- (Non-Refundable) on submission of a written application one day prior to the opening date from the office of Director General KPHA ATI Campus University Road Peshawar, otherwise bids submitted without these documents will not be processed for post qualification.
4. The bidders are required to quote their rates (electronically as well as in hard form of BOQ) "ABOVE/BELOW/AT PAR" on BOQ/Engineer Estimate. Only two digits after the decimal point shall be considered for evaluation purpose.
5. The bidders quoting their bids more than 10% below on Engineer's Estimate shall submit an Additional Bid Security as per KPPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22, Dated May 10, 2022 at the time of bid submission. The bidders should also submit an affidavit in the technical bid stating that the bid security and additional security (if any) is enclosed in the financial bids.
6. Tender Form Fee (non-refundable) @ 0.03% of the estimated cost in the shape of call deposit should be accompanied with technical bid.
7. All prevailing rules of KPPRA issued from time to time shall be observed during the procurement process.
8. All Bidders are required to be registered with the Khyber Pakhtunkhwa, Revenue Authority and FBR (with active status) Established under the Khyber Pakhtunkhwa, finance act, 2013.
9. A pre-bid meeting will be held in the office of the undersigned on **02-08-2024 at 11:00 AM**.
10. The competent authority reserves the right to reject any or all the bids assigning cogent reasons.
11. The bidders must visit the site prior to submission of bid to be fully well versed of the site conditions.
